## **PHILLIP ISLAND GOLF CLUB ('PIGC')**

However, greater credence is given to services the member has given to the Club outside of pure golf activities over a long period of time and the manner in which the member conducts him or herself.

Proposers should also refer to the policy document on the Club's website – Honorary Life Membership Guidelines (Policy).

The Board expects that the recommending document sets out how that member has demonstrated most or all of the following attributes:

- An on-going commitment to the Club over many years (at least 15 years cumulative membership);
- Outstanding service and contribution to the Club at all levels;
- A commitment which does not seek personal reward;
- Strong support for Club activities;
- Displayed a personal attitude and demeanour which reflects a dedication to the values of the Club;
- Displayed attributes of leadership and good role modelling which reflect credit upon the Club.
